### **GEL BLASTER RULES:**

WARNING: Gel Blaster can cause permanent blindness! Approved safety masks must be worn in firing areas at all times! There is a risk of minor bruising and eye damage while playing. Referees have **complete authority** on playing fields.

#### NO PHYSICAL CONTACT

- Gel Blaster is a non-contact sport.
- Do not do anything that may cause injury to either yourself or others.
- Do not climb on props, trees or woodpiles.

#### SAFE AND LEGAL WEAPONS HANDLING is a must.

- Gel Blasters (guns) are to stay in the firing areas **at all times.**
- Do not take Gel Blasters (guns) into a field safety shelter or reception area, except in a stout closed bag or other container.
- Private gel blasters (guns) are to be brought on site in a stout closed bag or other suitable container.
- No knives or other dangerous equipment to be brought on the playing field.

#### SMOKING, ALCOHOL AND DRUGS

- No smoking on playing fields. Smoking is permitted in the signed smoking areas only.
- No alcohol or drugs permitted.
- If you are drunk or have taken drugs, you are not permitted to play

**Indemnity and Waiver: PGE TWO**

- .1. Mango Hill Skirmish means Mango Hill Skirmish Pty Ltd. ACN\*\*\*\*\* and is herein referred to as 'MHS'.
- .2. Player means the person whose name and address is provided in Section 1 of this form.
- .3. By signing this form, the player acknowledge that the rules are understood and will be abided by.
- .4. The Players use of the facilities, services and equipment provided by MHS are undertaken at their own risk.
- .5. The player understands that participation in Laser Skirmish carries with it inherent risk. By signing this document, the player accepts and indemnifies MHS from liability:
  - .5.a. For any injury or damage occurring to the player personally; and
  - .5.b. For bodily injury to any third party arising from the use of the facilities, services and equipment provided by MHS.
